## Patient Lists – Secure Printers

The medical staff office has received numerous calls recently about patient lists being found on unsecure printers. This is a HIPAA violation. By making sure you are logged into the correct department, you will prevent any potential HIPAA violations from printing to the wrong printer. This will also ensure proper setup in Epic, such as flowsheet tabs for documentation, navigators, etc. You can verify your log in department by referencing the title bar at the top of your EPIC Hyperspace window. A tip sheet is available in Medical Staff 3-4133 if you need printing instructions. Please protect patient information and make sure you are printing to a secure printer!
