Preparing for ICD-10 Transition

Another friendly reminder that the ICD-10 code set will be required beginning Thursday, October 1, 2015. There is still time to prepare for the transition. The AHIMA: OptimizeHIT ICD-10 Training platform is available with specialty specific self-learning modules. There are several ways to access the tool.

User name is the email address that is on file in the Medical Staff Office. Password is "Medicine" or "medicine". You will be prompted to change your password on your first log in. Log In credentials are the same however you access the platform. CME credits are available through the platform for modules that are completed. Another resource is the <u>www.cms.gov</u> website and search under ICD 10 clinical concepts. There are multiple specialty specific guides available.

ICD-10 will be a big change for most of us. It will affect documentation, coding, billing, and ordering of tests. The best way to successfully transition and minimize any disruptions is to prepare early.

Dr. Ansari to Assume position of Medical Director of Pulmonary & Critical Care

Use of Disclaimers in the Electronic Medical Record

We have been seeing a rise in the use of disclaimers at the end of dictated reports and reports completed using M*Modal Fluency Direct speech recognition. These include statements such as:

- "Due to possible errors in transcription, there may be errors in documentation"
- "Due to voice recognition software, sound alike and misspelled words may be contained in the documentation"
- "I am not responsible for errors in transcription"

Such disclaimers are not recognized by CMS and have no legal standing. The provider is responsible for what is entered in the medical record. It is your responsibility to review and correct any information entered in the EMR, whether it is dictated, typed, through the use of templates, or the use of speech recognition software. By signing the documentation, you are stating that you have done this.
