Accreditation by the **National Accreditation Program for Rectal Cancer** (NAPRC) reflects our commitment to deliver specialized, comprehensive care for rectal cancer patients and recognizes our focus on personalized treatment plans, advanced surgical techniques, and a collaborative, multidisciplinary approach to achieve the best possible outcomes.

The **Commission on Cancer** (COC) recognizes our commitment to provide comprehensive, high-quality, multidisciplinary, individualized care. COC standards require facilities to create meaningful processes for implementation of patient-centered care.

National Accreditation Program for Breast Cancers (NAPBC) accreditation means we are voluntarily committed to providing the highest standards of care to patients with breast diseases. NAPBC requires a rigorous evaluation in program leadership, use of evidence-based practices, surgery, imaging and quality-improvement processes.

Our facility is fully accredited in mammography, stereotactic breast biopsy, breast ultrasound and breast MRI.

Covenant Cancer Care Center operates far above the accepted standard for accuracy, professionalism, patient safety and quality assurance to provide the best standard of patient care.

The ACR Lung Cancer Screening Center designation recognizes our facility has voluntarily committed to practice safe, effective diagnostic care for individuals at the highest risk for lung cancer.

ACR Radiation Oncology accreditation demonstrated our commitment to quality and patient safety and to providing exceptional oncology care, and it assures our patients of our commitment to excellence.

We are proud to present the 2024 Covenant Cancer Care Center Annual Report. As the new director for Covenant cancer programs, I am pleased to share our 2024 accomplishments and a few strategic initiatives for 2025.

2024 was a year of growth and changes across the cancer center. To address the growing patient numbers, Covenant hired three new nurse practitioners to support medical, radiation and surgical oncology: Lauren Hagarty, NP to work with Dr. Nourkeyhani; Lisa Wojdula, NP to work with Dr. Fugazzi and Dr. Zaki; and Amy Polzin, NP to support Dr. Bays. In addition, two new physicians will be joining our team in 2025, as we continue to recruit medical and gynecologic oncology physicians.

Through the year we reached many patients/community members through our community events. Covenant held screening events for breast and lung cancer as well as many support groups for our patients. And we were a Flag Ship sponsor for the American Cancer Society's Making Strides Against Breast Cancer Walk, with 80 staff and leader participants raising over \$11,000.

Continually striving to provide new services for our patients, the 2025 initiatives we are working on include: implementing Pluvicto treatments for prostate cancer; developing an advanced technology lung nodule clinic for biopsies and patient tracking; offering Bispecific T-cell Engager (BiTE) treatments in medical oncology, which uses the body's own immune system to attack cancer cells; improved scheduling for our infusion clinic; and strengthening relationships with the thumb hospitals and Covenant Cancer Care Center at Aspire Marlette.



TOP TEN CANCERS TREATED AT COVENANT HEALTHCARE




TOP FIVE SITES BY SEX





CANCER SCREENINGS OFFER PEACE OF MIND

At Covenant Cancer Care Center, we focus on the prevention, early detection and treatment of cancer.

Breast Cancer

Getting annual mammograms beginning at age 40 is key to the best outcomes. Consider these facts:

- 3D mammography is available at all Covenant breast screening locations to best aid in the protection against breast cancer.
- About 1 in 8 American women (12.4 percent) will develop invasive breast cancer in her lifetime.
- Breast cancer typically produces no symptoms when the tumor is small and most easily treated.
- Mammography has helped reduce breast cancer mortality in the U.S. by nearly 40 percent since 1990.

Lung Cancer

Screening for lung cancer is done with Low-Dose Computerized Tomography (LDCT). Quick and painless, it is performed without using x-ray dye or contrast. Consider these facts:

- Lung cancer is the leading cause of cancer deaths in the United States.
- 2,146 LDCT screenings were performed at Covenant in 2024. Out of these screenings, 17 cancers were detected.
- The overall relative 5 year survival rate for lung cancer is 27% according to the latest American Cancer Society facts and figures. This rate increases 64% at 5 years when the disease is found at an early, localized stage. Screening for Lung Cancer with LDCT is key to early detection.
- Adults between the age of 50-77 who are current, daily, cigarette smokers or have quit smoking within the past 15 years are at high risk for lung cancer. Someone who has smoked about 1 pack a day for 20 years or 1/2 a pack per day for 40 years is an example of a smoker who is eligible for screening.

Colorectal Cancer

Screening for colorectal cancer is done either with a stool-based test or with a colonoscopy. Consider these facts:

- Colorectal cancer is the second-leading cause of cancer-related deaths in the U.S.
- Colorectal cancer typically produces no symptoms when the tumor is small and most easily treated.
- When it is found at an early stage, the 5-year relative survival rate is 90 percent.
- Regular screening can even prevent colorectal cancer. With a colonoscopy, doctors can find and remove
 polyps before they turn into cancer.
- Patients of average risk should start regular screenings at age 45.

Registered Dietitian

The registered dietitian provides medical nutrition therapy to aid patients in coping with the side effects of treatments and the cancer itself. This therapy is essential in helping them maintain weight, increase strength and recover as quickly as possible. Our registered dietitian facilitates community education classes and meets with patients one-on-one.

Nurse Navigators

The role of the navigator is to identify possible barriers to care, and work with the patient, their family and the clinical
