### **GIFTS OF CASH**

Nothing is as simple as a gift of cash. This outright donation may be given as Restricted (to a specific cause) or Unrestricted (to support the general mission).

### **COVENANT CANCER CARE CENTER**

A one-stop location for all cancer treatment needs, the **Covenant Cancer Care Center** brings leading oncology services together under one roof. Patients benefit from the convenience, and health care providers enjoy greater efficiency and teamwork. Created to meet the growing demand for cancer care in the region, the Center is high-tech and professional, yet warm and friendly. The Covenant HealthCare Foundation was happy to work with donors to bring this center to life.

**Gifts to the Covenant HealthCare Foundation make a big impact in the medical care of our community.**

Making a donation to the Covenant HealthCare Foundation helps purchase items, large and small, beneficial to quality health care in the community. Consider purchases like:

**AvaSys Monitoring System**, provides 24/7 continuous video monitoring of patients at high risks for falls.

**Oscillating Ventilator** used to treat acute respiratory failure. Covenant is part of a select group of Michigan hospitals with this piece of equipment, and it is saving lives.

**Digital Retina Camera (RetCam)** is used to diagnose retinopathy of prematurity, an eye disease in premature infants that when undetected or untreated can lead to blindness.

Covenant Center for Autism, located at the Bay City Wilder Road MedExpress facility has been the recipient of **toys used for therapy and playground equipment**.

All these items were purchased with the help of Foundation funds, proving donor gifts really do make a difference!

### **GIFTS MADE FROM ACCUMULATED ASSETS**

#### **Gifts of Securities**

Gifts of appreciated stock held for more than one year can be a substantial gift at a low net cost to the donor. Donors receive a charitable deduction while avoiding federal capital gains tax that would otherwise be due on the sale of the asset. Securities worth less now than when purchased can be sold, proceeds donated, with the donor taking a capital loss on his or her tax return.

#### **Bequest**

A simple provision in a will or trust is an easy way to remember Covenant HealthCare in estate planning. Specific language is included in the documents, and can be obtained via the Foundation.

#### **Beneficiary Designations**

It is easy to leave a gift to Covenant HealthCare through a beneficiary designation on an existing insurance policy or retirement account (like an IRA). Simply designate Covenant HealthCare Foundation as the beneficiary of the full or partial amount of the policy or account.

#### **Gifts In-Kind**

Gifts In-Kind are non-monetary items of tangible personal property or other physical assets representing value to the Covenant HealthCare Foundation.

### **GIFTS PROVIDING INCOME TO THE DONOR**

Many donors find themselves in a position of holding assets that would make beautiful gifts at some point but currently are required to provide for present needs. Charitable trusts and gift annuities are two vehicles that provide current income, immediate tax deductions and can also leave a gift in the future.
