## We Need Your Assistance in Improving Medication Reconciliation!

There have been numerous cases of patients being discharged without a complete medication reconciliation (med rec) of their "prior to arrival" medications. Additionally, discharge medication lists are not matching the patients' AVS, potentially causing extended stays, readmissions and/or serious safety events. To best optimize this workflow, two teams are working on improving our process. HFAP accreditation states:

Medication reconciliation must be done at each key transitional point:

- Admission
- Transfer to a new unit with a change in level of care (higher or lower)
- Discharge
- Medication reconciliation must be completed within 24 hours of hospital admission

The following are not acceptable notes/orders:

- Resume previous orders
- Resume preoperative orders
- Resume all home medications

If you discontinue a medication it is very important that you list a reason. This will:

- Reduce the number of calls for clarification on medications
- Improve coordination of care for patients
- Prevent the unsafe restarting of a medication by another provider

Medication reconciliation can only be completed by a physician or advanced practice provider. A nurse can assist, but the provider must walk through the medication list with the nurse. Please reference Covenant administrative policies 3.80 and 3.49.1. As changes are made we will continue to keep you informed.

## Important Change to Admission Orders

A patient must only have a **SINGLE** admission order. If an inpatient admission order is already present on the patient's chart and you attempt to place another inpatient admission order, you will receive a hardstop and it will not allow you to sign the order. If the patient has an admission order and you are using an OrderSet, the admission order will no longer be available to choose from the OrderSet. If you need to update the attending provider, right-click on the patient's name from your Patient List and click "Assign Me". These changes will be effective on Thursday, April 21.
