Clinical Learning Environment Review (CLER) Residency Accreditation Survey Update

The Clinical Learning Environment Review Accreditation Survey for the Residency Program will be held on September 5 and 6. The surveyors will be touring CMU and the hospital, interacting with faculty, residents, staff and patients. As a reminder, they will be focusing on Patient Safety and Quality, Transitions and Hand-Offs, and Supervision. They may ask about:

What are the top 3 performance improvement/patient safety priorities at Covenant?

- 1. Reduction in hospital wide 30-day readmission rate
- 2. Improved hand hygiene compliance
- 3. Reduction in falls with injury rate

What are some other improvement/patient safety priorities?

- 1. Promoting high reliability and culture of safety
- 2. Reducing hospital acquired conditions
- 3. Improved core measure adherence
- 4. Improved medication safety
